

# Organisation Consent & User Account Form

### Organisation Consent

As part of the registration process for the Olympic Boxing Qualifying Tournaments for the Boxing Competition at the Olympic Games Paris 2024, each National Olympic Committee (NOC) and Boxing National Federation (NF) seeking accreditation of its boxing Athletes, Team Officials and Extra Team Officials is responsible for collecting and submitting to the International Olympic Committee (the "IOC Paris 2024 Boxing Unit") certain personal data (such as name, contact information and documents) and other relevant registration information for the purposes of accreditation, sport entries and the organisation of the Olympic Boxing Qualifying Tournaments on behalf of each applicant for whom it requests an accreditation.

The conditions applicable to the processing of an applicant's personal data are described in the Information Notice on the Processing of Personal Data of Participants and Other Accredited Persons, Annex 1 to the Conditions of Participation for Participants; and in the Parent/Legal Guardian Acknowledgment of Consent for Minors, Annex 3 to the Conditions of Participation for Participants.

#### The NOC and NF confirms and undertakes the following:

- 1. The NOC and NF are validly represented by the signatories below, who have been duly authorised and have all necessary powers to represent the NOC and NF for the purposes of the NOC and NF giving this undertaking.
- 2. The NOC and NF are aware of the Information Notice on the Processing of Personal Data of Participants and Other Accredited Persons, and understand for what purposes and in what manner each applicant's personal data will be processed by the IOC Paris 2024 Boxing Unit and relevant third parties in relation to the accreditation, sport entries and staging of the Olympic Boxing Qualifying Tournaments, including after the closing of such events.
- 3. Before submitting any applicants' personal data to the IOC Paris 2024 Boxing Unit, the NOC and NF shalll:
  - a. inform the relevant applicants (and, for applicants who are minors or without legal capacity under the laws of their country of residence, their parents or legal guardians) of the conditions applicable to the processing of each applicant's personal data as described in the Information Notice on the Processing of Personal Data of Participants and Other Accredited Persons, including with regards to rights they may have under applicable law to access, rectify or delete their applicants' personal data and ensure that they understand these conditions and comply with any further legal requirements for the processing of personal data in accordance with such Information Notice;
  - b. where required under the applicable laws and regulations applicable to the collection, processing and transfer of applicants' personal data, obtain the applicants' (and, for applicants who are minors or without legal capacity under the laws of their country of residence their parents' or legal guardians') express consent in writing to the transfer of personal data, including but not limited to those categorised in Section 5 c or 5 e of the Information Notice, from the NOC and NF to the IOC Paris 2024 Boxing Unit, and any other subsequent transfer thereof from the IOC Paris 2024 Boxing Unit to other recipients described in the Information Notice (note: insofar as EU General Data Protection Regulation 2016/679 may also apply to the processing of personal data contemplated in the Information Notice in particular vis-à-vis applicants coming from a member State of the European Union, legal grounds other than express consent will apply to enable the processing of personal data as described in the Information Notice); and
  - c. ensure that, to the best of its knowledge based on all verification means at the NOC's and NF's disposal, each applicant's personal data transmitted to the IOC Paris 2024 Boxing Unit is accurate, complete and up to date.

- 4. Upon request from the IOC Paris 2024 Boxing Unit, the NOC and NF shall (i) promptly provide evidence of the written authorisation and/or consent given by any relevant applicants (and their parents or legal guardians, if applicable) to the processing of their personal data under the conditions described under the Information Notice, and (ii) keep and retain such evidence during the retention period of personal data set out in the Information Notice.
- 5. The NOC and NF shall, upon request of the IOC Paris 2024 Boxing Unit, provide assistance to the IOC Paris 2024 Boxing Unit for any request related to the fulfilment of their obligation to respond to applicants' requests for exercising their right to access, rectify or delete their personal data, as well as for any personal data security breach relating to applicants.
- 6. The NOC and NF shall comply with all laws and regulations applicable to the collection, processing and transfer of applicants' personal data by the NOC and NF as necessary for carrying out its responsibilities under this Organisation Consent Form.
- 7. The NOC and NF shall:
  - a. inform the relevant applicants (and, for applicants under who are minors under the laws of their country of residence, their parents or legal guardians) of the provisions relating to the capture and use of their image during the Olympic Boxing Qualifying Tournaments, as well as other intellectual property provisions applicable to them, as described in the Information Notice on the Processing of Personal Data of Participants and Other Accredited Persons; and
  - b. obtain the express consent of the relevant applicants (and, for applicants under who are minors under the laws of their country of residence, their parents' or legal guardians') regarding the capture and use of their image during the Olympic Boxing Qualifying Tournaments, as well as regarding the other intellectual property provisions applicable to them, as described in the Information Notice on the Processing of Personal Data of Participants and Other Accredited Persons.

All entries for Olympic Boxing Qualifying Tournaments require NOCs to confirm the technical and medical standard of the athletes. This means that if a NF has not recommended athletes for participation in the Qualifying Tournaments and/or the Olympic Games themselves, the NOC has the authority to enter its athletes without the recommendation of the NF.

#### **User Account**

The User Account Form is used to create access to the Event-Works Registration System. The NOC and NF should make sure that the person nominated to access the system has all the necessary information and permissions to do so on behalf of the NOC and NF. All information submitted will be considered truly and duly validated internally by the corresponding authorities. Only the person assigned by the NOC and NF to access the Event-Works Registration System will receive the communications regarding the accreditation and sports entries processes. A registration link will not be granted until the form has been completed, signed and submitted.

## Personal Data Processing Notice

The personal data contained on this form are collected by the IOC Paris 2024 Boxing Unit, in its capacity as data controller, for the purposes of (i) providing access to the relevant user to the Event-Works Registration System, and (ii) submitting the applicants' information within the Event-Works Registration System.

All fields are mandatory, and relevant information must be provided in order to complete the accreditation process.

The data will only be kept by the IOC Paris 2024 Boxing Unit for the duration that is necessary to complete registration for the Olympic Boxing Qualifying Tournaments.
